## T E R M S

**ALL VENDORS** MUST COMPLETE A TEN SLEEP ITINERANT MERCHANT PERMIT GOOD FOR 48 HOURS. THIS PERMIT IS GOOD FOR THE ENTIRE FESTIVAL (5:00 PM FRIDAY TO 5:00 PM SUNDAY). **ALL VENDORS** AND THEIR STAFF MUST WEAR WRIST BAND TICKETS AT ALL TIMES. **ALL FOOD VENDORS** MUST PROVIDE A COPY OF A CURRENT WYOMING STATE FOOD HANDLERS PERMIT WITH THIS AGREEMENT.

**VENDORS MAY NOT SELL** CARBONATED BEVERAGES, WATER OR BEER. NO GLASS CONTAINERS OR BOTTLES ARE ALLOWED AT THE FESTIVAL. DOGS ARE NOT PERMITTED IN THE PARK BY TOWN ORDINANCE.

VENDOR SPACES ARE AVAILABLE ON A FIRST COME, FIRST SERVED BASIS. VENDORS ARE ALLOWED NORTH OF THE LINE FROM THE SOUTHERN WALL OF THE TEN SLEEP MUSEUM AND THE BIG TRAILS SCHOOL HOUSE EAST TO THE PARKING RAIL. NO VENDORS OTHER THAN THE FESTIVAL T-SHIRT AND CD BOOTH WILL BE ALLOWED WEST OF THE PARKING RAIL AND SOUTH OF THE PREVIOUSLY MENTIONED LINE.

ALTHOUGH THERE IS SOME ELECTRIC POWER AVAILABLE, NOWOODSTOCK **DOES NOT GUARENTEE** POWER FOR YOUR ENDEAVOR. GENERATORS MAY BE USED TO POWER YOUR SPACE. IF YOU ARE USING A GENERATOR, PLEASE SET UP ON THE NORTH END OF THE PARK SO NOISE FROM THE GENERATOR DOES NOT AFFECT THE FESTIVAL SOUND SYSTEM.

NOWOODSTOCK TAKES NO RESPONSIBILITY FOR LOSSES OR THEFT. NOWOODSTOCK PROMISES NOTHING THAT IS NOT EXPLICITLY STATED IN THIS AGREEMENT.
